PCOA'S COMMUNITY SERVICE SYSTEM PROVIDED 161,365 HOURS OF IN-HOME CARE FOR 1,689 FRAIL, OLDER ADULTS AND YOUNGER PERSONS WITH DISABILITIES WHO NEEDED ASSISTANCE WITH BATHING, LAUNDRY, CHANGING BED LINENS, CLEANING THEIR HOMES AND SHOPPING FOR GROCERIES.

PCOA IMPROVED THE NUTRITIONAL INTAKE OF 3,188 OLDER ADULTS THROUGH THE PROVISION OF 267,198 WELL-BALANCED PREPARED MEALS. THESE MEALS WERE SERVED AT 13 PIMA COUNTY SENIOR LUNCH SITES AND DELIVERED TO THE HOMES OF FRAIL OLDER ADULTS WHO COULD NO LONGER SAFELY COOK AND HAD DIFFICULTY LEAVING THEIR HOMES. 82% OF CONGREGATE AND 87% OF HOME DELIVERED MEAL RECIPIENTS REPORTED THE MEAL WAS THEIR MAIN COOKED MEAL OF THE DAY.
